Change to isolation period for close contacts.

On the 14th December 2020 the [Department for Health & Social Care](#) released the [UK Chief Medical Officers' statement](#) regarding the reduction in the number of days people have to self-isolate from 14 days to 10 days. the change applies from 00:01am on Monday 14 December.

The change to the isolation period for close contacts will apply to all those who are currently self-isolating including those who commenced self-isolation before Monday the 14th December, their self-isolation can now end after 10 days.

Self-isolation is essential to reducing the spread of COVID as it breaks the chains of transmission.

People who return from countries which are not on the travel corridor list should also self-isolate for 10 days instead of 14 days.

People who test positive should continue to self-isolate for 10 days from onset of symptoms or 10 days from point of taking a positive test if asymptomatic.

Risk Assessment update-All references to 14-day isolation contained within the COVID-19 risk assessment are to be changed to 10-days isolation.
